## Non-Applicability of Right to Information Act, 2005 to

## R. C. Patel Educational Trust's

## Institute of Management Research and Development Shirpur

- a) Right to Information Act 2005 is not applicable to R. C. Patel Educational Trust's Institute of Management Research and Development Shirpur, since there is no direct involvement in the decision making of the Trust and Institute of Management Research and Development Shirpur, by the Government.
- b) It is exclusively managed and administered by the Trustees of the Trust which mean that the Government has no direct control on the Institute / Trust.
- c) Thus, there is no fulfilment of the conditions to be called as "Public Authority" to make applicable the Right to Information Act.

In view of the above and various judgments of apex court/s and notifications, the provisions of the Right to Information Act, 2005 are not applicable to the R. C. Patel Educational Trust's Institute of Management Research and Development Shirpur.
