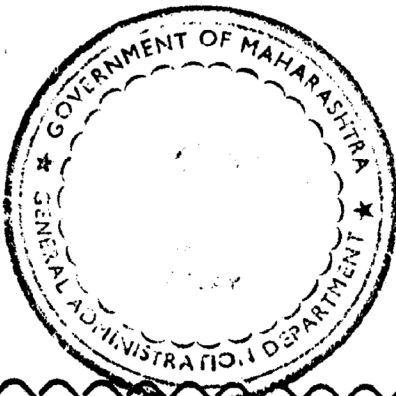

The Scrutiny Committee appointed for the purpose, has done primary scrutiny of information given in the application and concerned documents enclosed with the application. On the basis of conclusion drawn by the Scrutiny Committee as well as the presentation made by the office-bearers of the institution during the hearing held before me on 3<sup>rd</sup> July, 2007 with concerned institution, I am satisfied that above mentioned institution is established and maintained by a person or group of persons from amongst the linguistic (Gujrathi) minorities declared by the State Government under the criteria determined vide Government Resolution, General Administration Department, No.ASS-2006/634/C.R.63/2006/35, dated 11<sup>th</sup> June, 2007. Consequently, it is hereby declared that the aforesaid institution is a Minority Educational Institution within the meaning of section 2 (g) of the National Commission for Minority Educational Institutions Act, 2004 and under Article 30 of the Constitution of India.

This No Objection Certificate shall stand for the Maharashtra State only. The linguistic minority status granted to above mentioned institution shall be applicable to all the educational units conducted by the institution.

The linguistic minority status granted to aforesaid educational institution shall be valid for three years from the academic year 2007-2008. It shall be mandatory for the concerned institution to fulfil expressly and specifically the criteria and conditions prescribed vide Government Resolution, General Administration Department, No.ASS-2006/634/C.R.63/2006/35, dated 11<sup>th</sup> June, 2007.
